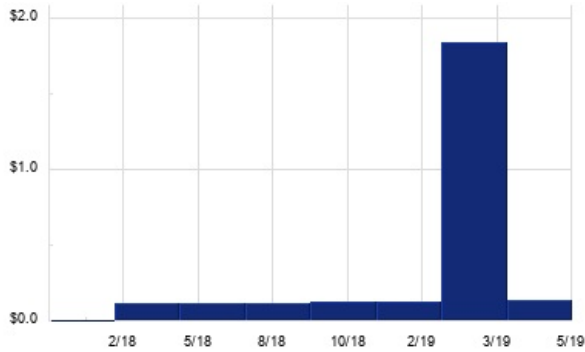

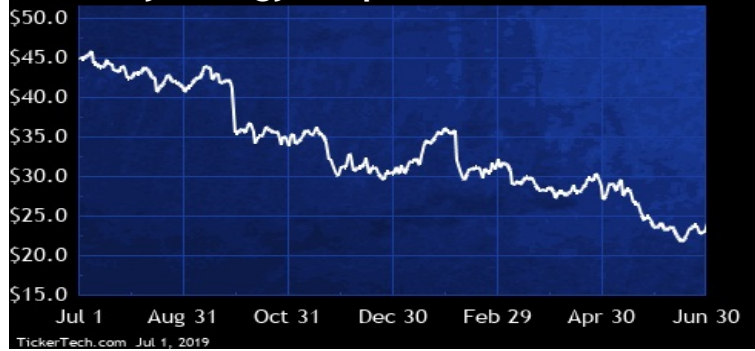

Peabody Energy Corp

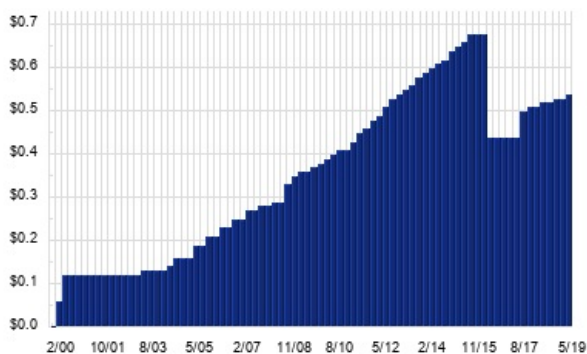


Peabody Energy is a coal company, engaged in the mining of thermal coal for sale primarily to electric utilities and metallurgical coal for sale to industrial customers. Co. owns interests in several coal mining operations located in the U.S. and Australia. Co. has a majority interest in several of those mining operations and an equity interest in Middlemount Coal Pty Ltd. (Middlemount), which owns the Middlemount Mine in Queensland, Australia. In addition to its mining operations, Co. markets and brokers coal from other coal producers, both as principal and agent, and trade coal and freight-related contracts through trading and business offices in the U.S., Australia, China, and the U.K.

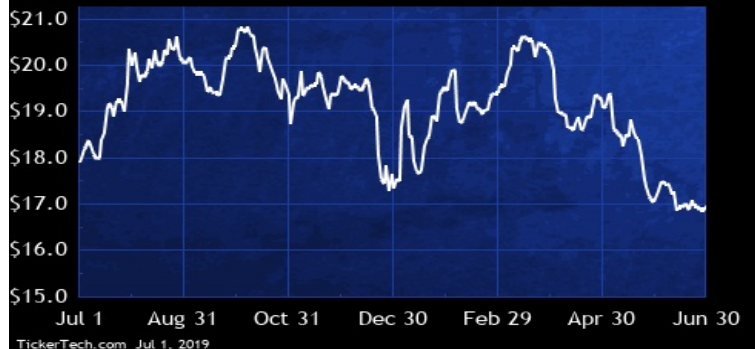

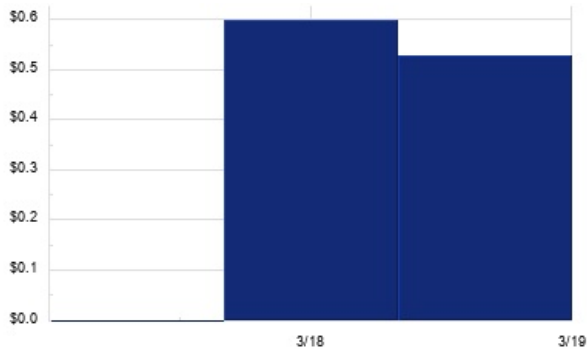


Alliance Resource Partners is a producer and marketer of coal to U.S. utilities and industrial users. Co. produces a range of steam coal with varying sulfur and heat contents. As of Dec 31 2016, Co. operated eight underground mining complexes in Illinois, Indiana, Kentucky, Maryland and West Virginia. Co. also operates a coal loading terminal on the Ohio River at Mt. Vernon, IN. Co.'s mining activities are conducted in two geographic regions referred to in the coal industry as the Illinois Basin and Appalachian regions. Also, at Dec 31 2016, Co. had approximately 1.76 billion tons of proven and probable coal reserves in Illinois, Indiana, Kentucky, Maryland, Pennsylvania and West Virginia.

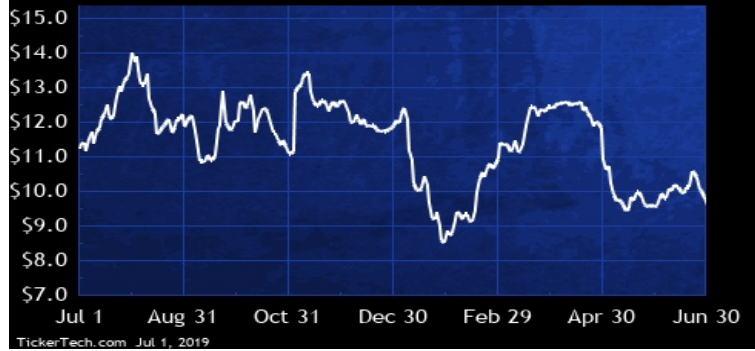

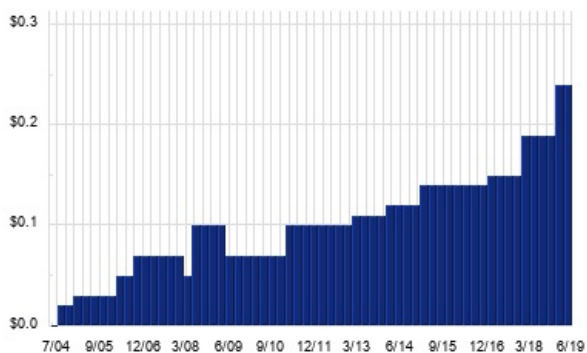

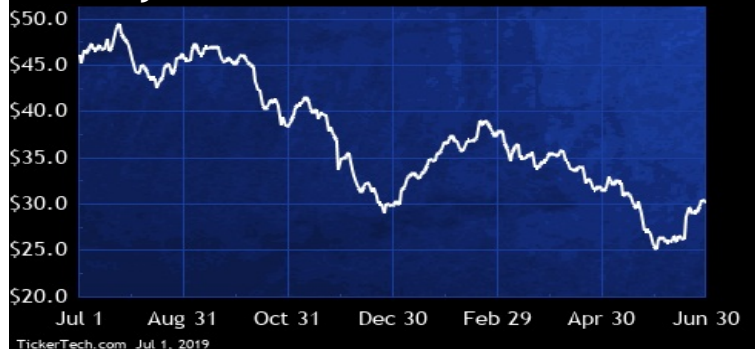

Steel Dynamics Inc.

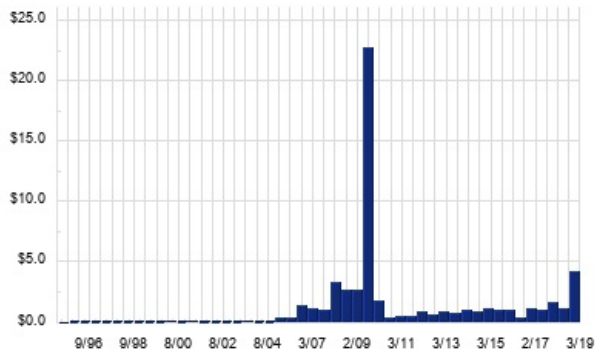

Co. manufactures and sells steel products, processes and sells recycled ferrous and nonferrous metals, and fabricates and sells steel joists and deck products. Co.'s segments are: Steel, which produce steel from ferrous scrap and scrap substitutes, utilizing casting, automated rolling mills and several downstream steel coating and bar processing lines, and its Iron Dynamics; metals recycling, which involve the purchase, processing, and resale of ferrous and nonferrous scrap metals into reusable forms and grades; and steel fabrication, which produces steel building components, including steel joists, girders, trusses, and steel deck.

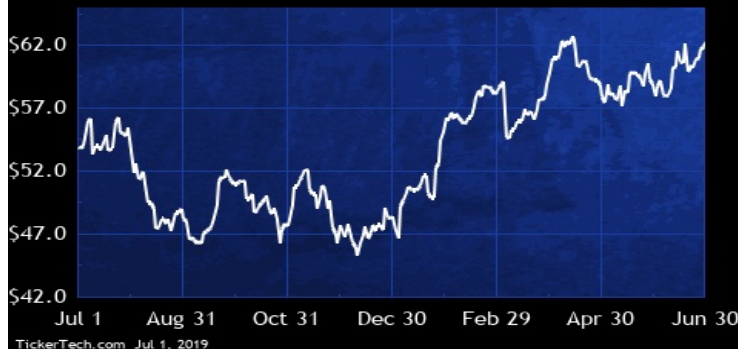

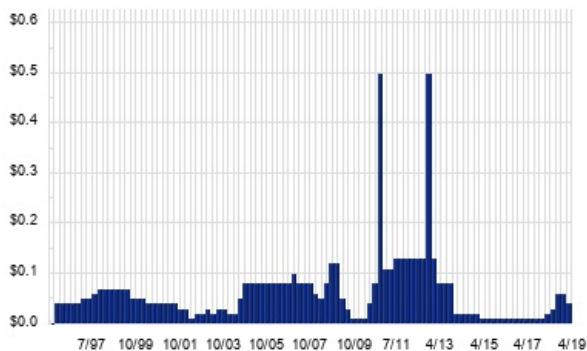


Rio Tinto is engaged in finding, mining and processing mineral resources. Co. has four product groups: iron ore, which supplies the global seaborne iron ore trade; aluminium, which includes bauxite mines, alumina refineries, and aluminium smelters; Copper and Diamonds, which has managed operations in Australia, Canada, Mongolia and the U.S., and non-managed operations in Chile and Indonesia, with by-product including gold, silver, molybdenum and others such as sulphuric acid, rhenium, and lead carbonate; and Energy and Minerals, which comprises mining, refining and marketing operations across borates, coal, iron ore concentrate and pellets, salt, titanium dioxide and uranium sectors.

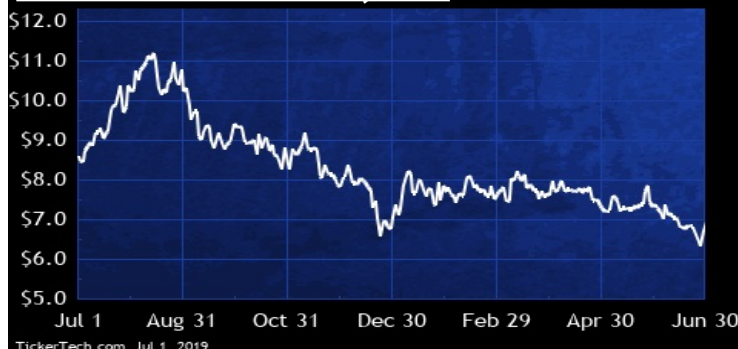

Friedman Industries, Inc.

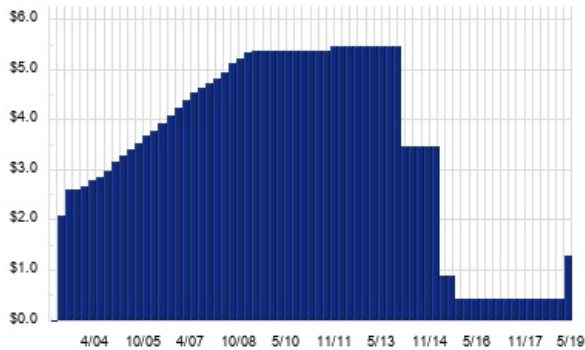


Friedman Industries manufactures and processes steel products and operates in two segments; coil products and tubular products. The coil product segment consists of the operation of hot-roll coil processing facilities. This segment sells its prime grade inventory under the Friedman Industries name but also maintains an inventory of non-standard coil products, consisting of mill secondary and excess prime coils. The tubular product segment consists of Co.'s Texas Tubular Products division (TTP), which operates electric resistance welded pipe mills. TTP has a pipe finishing facility that threads and couples oil country tubular goods and performs other services in the pipe finishing process.

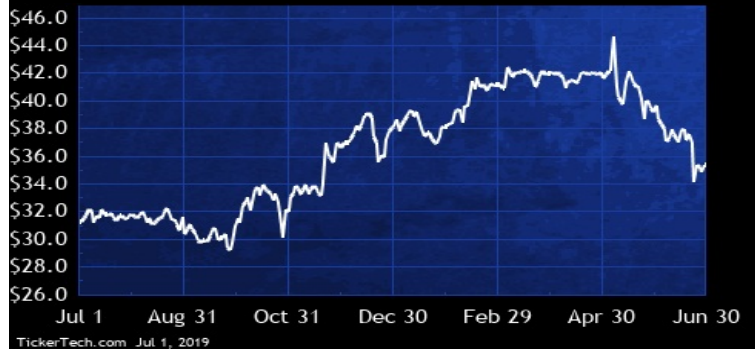

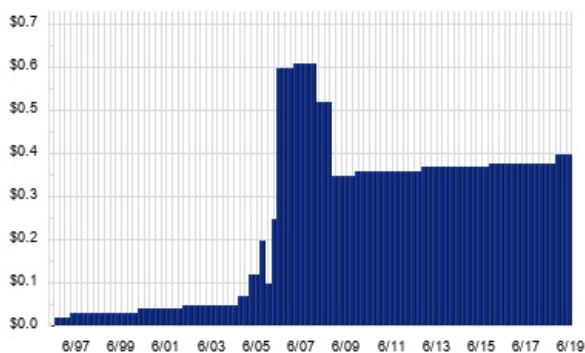

Co. has three segments: coal royalty and other, which consists primarily of coal royalty properties and coal related transportation and processing assets; soda ash, which, via Ciner Resources LP, mines trona, processes it into soda ash, and distributes the soda ash both domestically and internationally into the glass and chemicals industries; and construction aggregates, which operates hard rock quarries, an underground limestone mine, sand and gravel plants, asphalt plants and marine terminals.

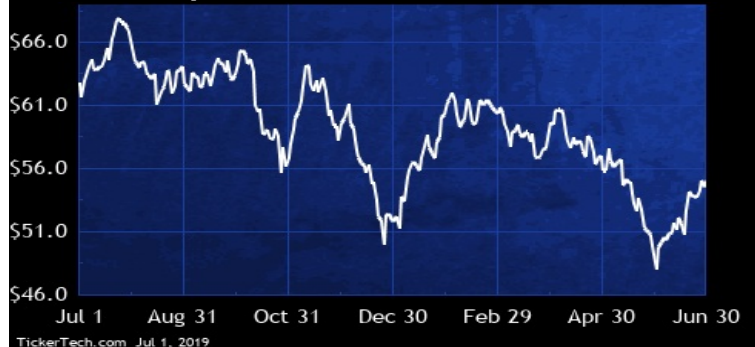

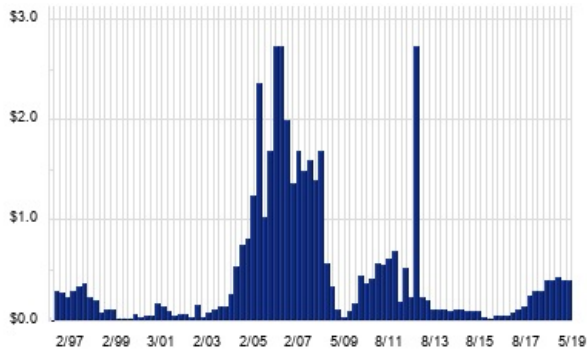


Nucor manufactures steel and steel products. Co.'s operations include international trading and sales companies that buy and sell steel and steel products. Co.'s segments are: steel mills, which produces sheet steel, plate steel, and structural steel, and bar steel; steel products, which produces hollow structural section steel tubing, electrical conduit, steel joists and joist girders, steel deck, cold finished steel, steel fasteners, metal building systems, and wire and wire mesh; and raw materials, which produces direct reduced iron (DRI), brokers ferrous and nonferrous metals, pig iron, hot briquetted iron and DRI, supplies ferro-alloys, and processes ferrous and nonferrous scrap metal.

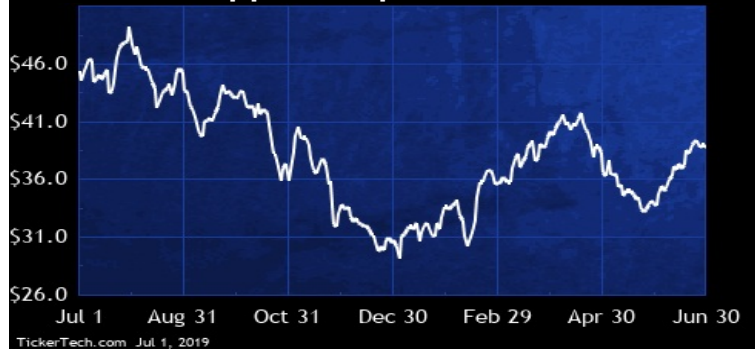

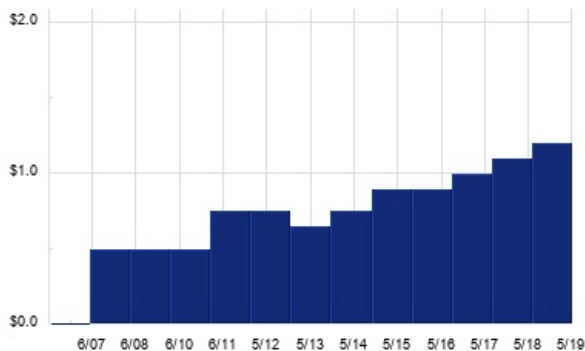


Southern Copper is a copper producer. Co.'s mining, smelting and refining facilities are located in Peru and Mexico and Co. conducts exploration activities in those countries and in Argentina, Chile and Ecuador. Co.'s Peruvian copper operations involve mining, milling and flotation of copper ore to produce copper concentrates and molybdenum concentrates, the smelting of copper concentrates to produce blister and anode copper, and the refining of anode copper to produce copper cathodes. Co.'s Mexican operations are conducted through its subsidiary, Minera Mexico, S.A. de C.V., which engages primarily in the mining and processing of copper, molybdenum, zinc, silver, gold and lead.

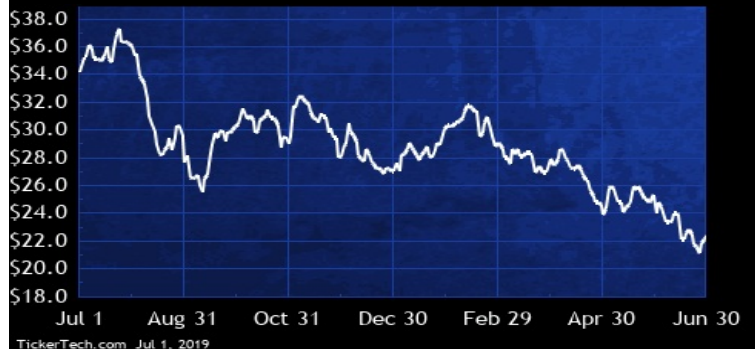
