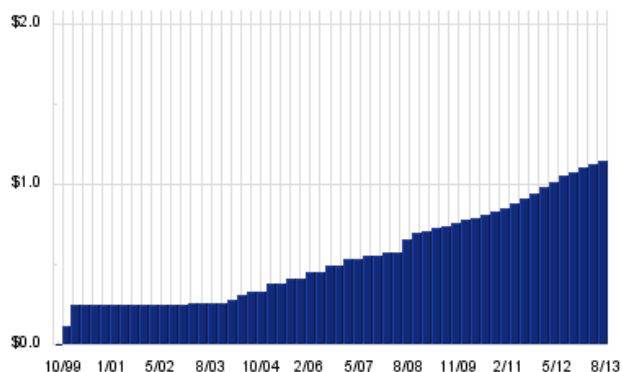

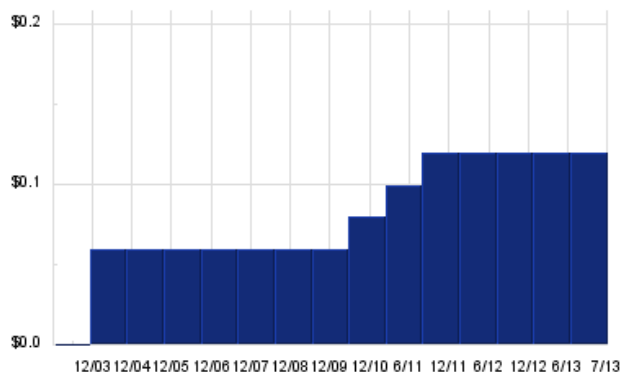

In addition, Co. develops and markets additional services, which include ash and scrubber sludge removal, coal yard maintenance and arranging alternate transportation services. 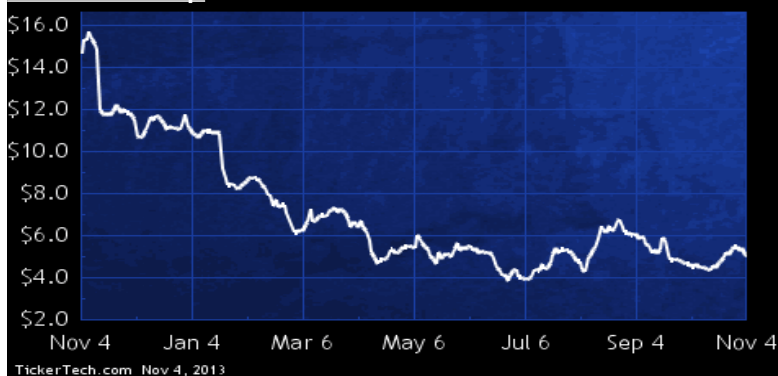

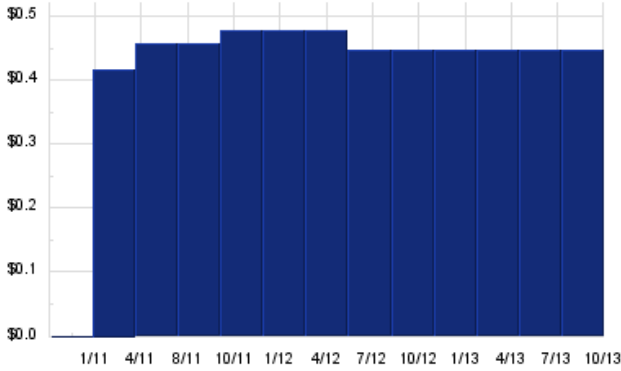

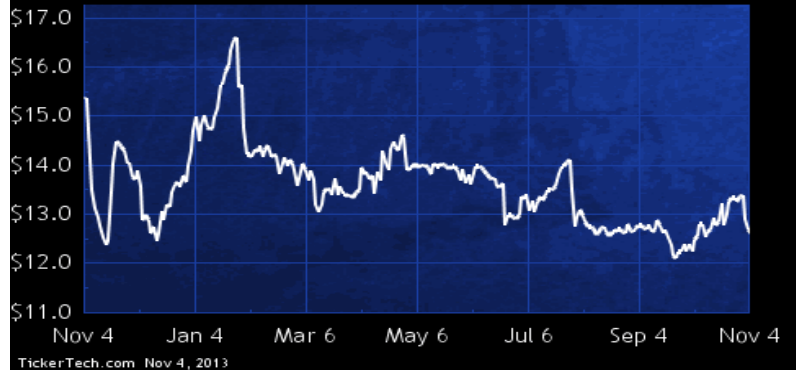
RNO Dividend History

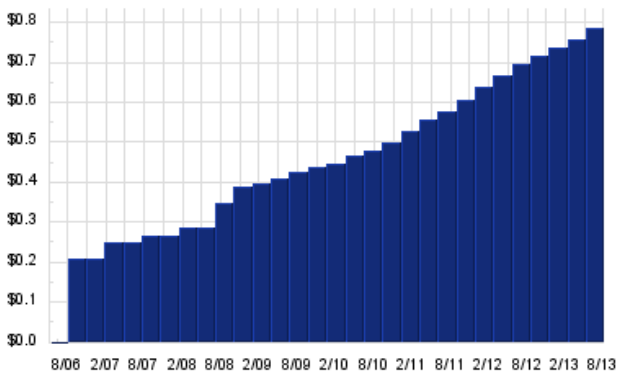

Co. also manages and leases coal properties and collects royalties from such management and leasing activities. Southern Copper produces copper, molybdenum, zinc and silver. Co.'s mining, smelting and refining facilities are located in Peru and in Mexico, and it conducts exploration activities in those countries and in Argentina, Chile and Ecuador. Co.'s Peruvian copper operations involve mining, milling and flotation of copper ore to produce copper concentrates and molybdenum concentrates; the smelting of copper concentrates to produce anode copper; and the refining of anode copper to produce copper cathodes. Co. also produces molybdenum concentrate and refined silver. Co.'s Mexican operations are primarily engaged in the mining and processing of copper, molybdenum, zinc, silver, gold and lead.

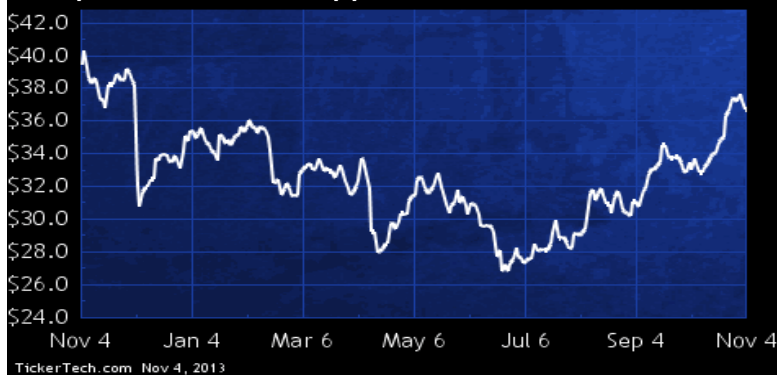

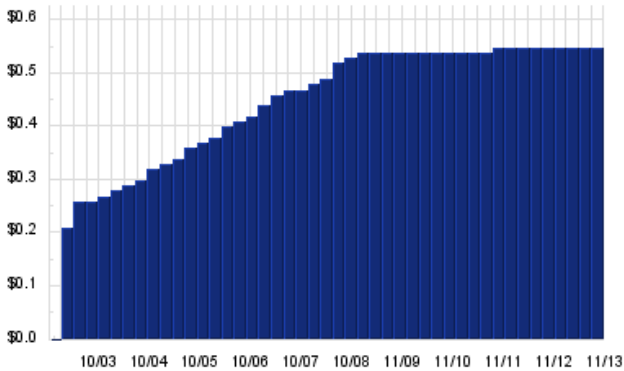

Freeport-McMoRan Copper & Gold is a mining company. Co.'s portfolio of assets includes the Grasberg minerals district in Indonesia, mining operations in North and South America, and the Tenke Fungurume minerals district in the Democratic Republic of Congo. Co.'s products include copper concentrate, cathode and continuous cast copper rod; gold products; molybdenum and molybdenum-based chemicals; as well as cobalt hydroxide, silver and other metals such as rhenium and magnetite. At Dec 31 2012, Co. had consolidated recoverable proven and probable reserves of 116.50 billion pounds of copper, 32.5 million ounces of gold, 3.42 billion pounds of molybdenum, and 321.4 million ounces of silver.

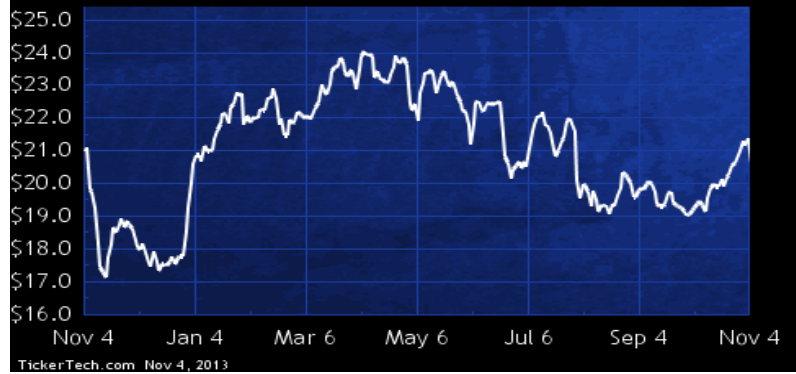

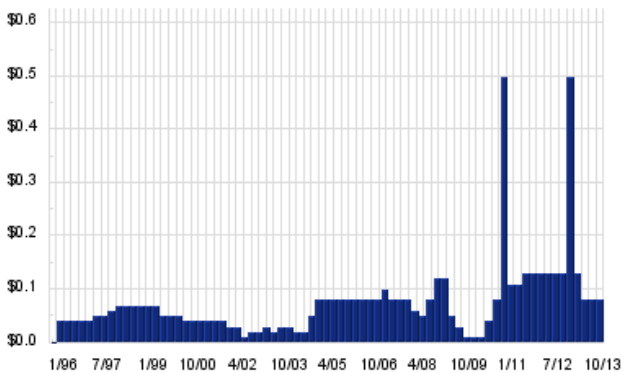


Natural Resource Partners is engaged in the business of owning, managing and leasing mineral properties in the U.S. Co. owns coal reserves in three U. S. coal-producing regions: Appalachia, the Illinois Basin and the Western U. S., as well as lignite reserves in the Gulf Coast region. As of Dec 31 2012, Co. owned or controlled approximately 2.37 billion tons of proven and probable coal reserves, and approximately 500.0 million tons of aggregate reserves in a number of states across the country. Co. does not operate any mines, but leases its reserves to mine operators under leases that grant the operators the right to mine and sell Co.'s coal reserves in exchange for royalty payments.

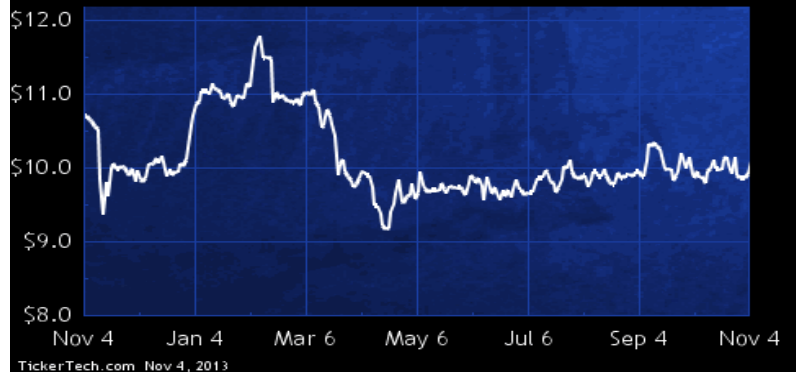
